II. AMENDMENTS. The parking fines authorized by 253-18(A) of the Code of the Village of St. Johnsville are hereby, and hereafter, established as follows:

1. General Violation	\$25.00
2. No parking at intersection	\$25.00
3. No parking in excess of two hours	\$25.00
4. No parking 2:00 AM to 6:00 AM	\$25.00
5. No twenty-four hour parking	\$25.00
6. No blocking driveway	\$25.00
7. No parking on sidewalk	\$25.00
8. No parking within 15 feet of fire hydrant	\$50.00
9. No blocking of designated fire lane	\$55.00
10. No parking in handicapped zone without permit	\$50.00
11. Uninspected motor vehicle	\$30.00
12. Unregistered motor vehicle	\$50.00
