# ARTICLE I Moving Violations

#### § 253-1. Speeding.

Thirty miles per hour is hereby established as the maximum speed at which vehicles may proceed within the corporate limits of this Village, except as hereinbelow designated as the established maximum speed, to wit:

- A. Fifteen miles per hour on Lion Avenue between New York State Route 5 and Crouse Boulevard.
- B. Fifteen miles per hour on Monroe Street between Averill Street and the David H. Robbins Elementary School parking lot.
- C. Twenty miles per hour on Monroe Street between Center Street and Averill Street.

# § 253-2. One-way traffic.

The following streets, or portions thereof, and exits from public parking lots are hereby established as one-way traffic in the directions specified, to wit:

- A. Mechanic Street is hereby designated as a one-way street with traffic to proceed only in a southerly direction from West Main Street to East Liberty Street.
- B. Washington Street is hereby designated as a one-way street with traffic to proceed only in a northerly direction from East Main Street to Monroe Street.
- C. Exiting of traffic from the public parking lot situated west of the Central Hotel building is hereby designated as one-way with traffic to proceed only in a southerly direction to Park Place.

#### § 253-3. Stop signs and yield signs.

A. New York State Route 5, Main Street, is hereby designated as a through highway and stop signs shall be erected on the following entrances thereto:

## § 253-4. Weight and length limitations.

Weight and length of vehicles shall be limited on certain streets, or portions thereof.

A. Liberty Street is hereby designated a weight/length-of-vehicle limitation street with the gross vehicle weight limited to nine tons and overall vehicle length limited to 30 feet.

# § 253-5. No right turn on red.

A. At the intersection of North Division Street and West Main Street a right turn shall not be permitted upon a red traffic light.

# ARTICLE II Parking Violations

#### § 253-6. General violations.

The provisions of this article shall apply except when it shall be necessary to stop a vehicle to avoid conflict with other traffic, or to be in compliance with the directions of a police officer or official traffic control device.

# § 253-7. Overnight parking.

- A. The parking of vehicles is hereby prohibited on any streets or highway in this Village from, and including, November 1 of each calendar year to, and including, March 31 of the succeeding calendar year between the hours of 2:00 a.m. and 6:00 a.m. daily, Sunday and legal holidays included, any other provision of this chapter to the contrary notwithstanding.
- B. Parking is prohibited on the west side of the public parking lot situated west of the Central Hotel building southerly to Park Place from, and including, November 1 of each calendar year to, and including, March 31 of the succeeding year between the hours of 2:00 a.m. and 6:00 a.m. daily.

# § 253-8. Parking prohibited.

The parking of vehicles in this Village is prohibited in the following locations and at such times that may be designated:

# § 253-9. Parking prohibited at intersections.

The parking of vehicles in this Village is prohibited at, or near, the following intersections, as indicated:

# § 253-10. Two hour parking.

Parking shall be prohibited on the following streets, highways and public parking lots in the Village for any period of time in excess of that respectively herein below designated:

- A. On the north side of East Main Street and West Main Street between North Division Street and Kingsbury Avenue, and on the south side of East Main Street and West Main Street between Church Street and Kingsbury Avenue, for any continuous period in excess of two hours daily between the hours of 8:00 a.m. and 6:00 p.m., Sundays and legal holidays excepted.
- B. On the east and west sides of Bridge Street between Main Street and the intersection of Mohawk Street for any continuous period in excess of two hours daily between the hours of 8:00 a.m. and 6:00 p.m., Sundays and legal holidays excepted.
- C. On the east and west sides of Kingsbury Avenue between East Main Street and New Street for any continuous period in excess of two hours daily between the hours of 8:00 a.m. and 6:00 p.m., Sundays and legal holidays excepted.
- D. On the west side of Center Street from the intersection of Cross Street southerly for a distance of 190 feet for any continuous period in excess of two hours daily between the hours of 8:00 a.m. and 6:00 p.m. Sundays and legal holidays excepted.<sup>1</sup>

# § 253-11. Twenty-four hour parking.

Parking for any continuous period in excess of 24 hours is prohibited on the following public highways, streets and public parking lots in the Village, to wit:

- A. On the north and south sides of Park Place.
- B. In any public parking lot.2

## § 253-12. Statutory parking restrictions. <sup>3</sup>

Blocking of driveways, parking on sidewalks, and parking near fire hydrants shall be restricted as set forth in Vehicle and Traffic § 1202.

# ARTICLE III Handicapped Parking

#### § 253-13. Designated areas.

The following locations shall be designated handicapped parking areas and, as subsequently applicable, such others as may be particularly selected by the Chief of Police of the Village of St. Johnsville Police Department and approved by the Board of Trustees:

- A. One in front of Kinney's drugstore on Park Place.
- B. One in front of the Big M grocery store on Park Place.
- C. One in front of St. Johnsville Medical Associates, P.C. on East Main Street.
- D. One adjacent to the handicapped access ramp located off the Community House parking lot.
- E. One in front of the Central National Bank on West Main Street.
- F. One in front of St. Patrick's Catholic Church on the east side of Center Street, Saturday only.
- G. One on the east side of Center Street at the corner of the intersection of Center Street and Monroe Street, Sunday only.
- H. One at the southwest corner of Main Street at the intersection of Main Street with Bridge Street.
- One on the east side of Kingsbury Avenue in front of the Margaret Reaney Memorial Library.

# § 253-14. Violations. 4

In accordance with the provisions of §§ 1203-a, 1203-b, 1203-c and 1203-d of the New York State Vehicle and Traffic Law, the driver of any motor vehicle which is parked in any handicapped parking zone without a handicapped parking permit issued by an authorized agent, or without a New York State plate designating such vehicle as a handicapped person vehicle, shall have committed a parking violation herein.

# ARTICLE IV Uninspected or Unregistered Motor Vehicles

#### § 253-15. Uninspected motor vehicles.

In accordance with § 306(b) of the Vehicle and Traffic Law of the State of New York, the driver of any motor vehicle which is parked on any public street or public parking lot of this Village, either without a certificate of inspection as required in Article 5 of the New York

State Vehicle and Traffic Law or, the display of such certificate of inspection upon the vehicle or affixed to the registration certificate, shall have committed a parking violation herein.

### § 253-16. Unregistered motor vehicles.

In accordance with § 401, Subdivision 1, of the Vehicle and Traffic Law of the State of New York, the driver of any motor vehicle which is parked upon a public street or public parking lot of this Village without a certificate of registration displayed on the windshield, as required in Article 14 of the Vehicle and Traffic Law of the State of New York, shall have committed a parking violation herein.

# ARTICLE V Penalties for Offenses

# § 253-17. Moving violations. 5

Every person convicted of a traffic infraction for a violation of any provision of this local law which is not a violation of the Vehicle and Traffic Law of the State of New York shall be punishable as follows:

- A. Upon a first conviction, such person be punished by a fine of not more than one \$100 or by imprisonment for not more than 15 days, or by both such fine and imprisonment.
- B. Upon a second such violation within 18 months thereafter, such person shall be punished by a fine of not more than \$200 or by imprisonment for not more than 45 days, or by both such fine and imprisonment.
- C. Upon a third or subsequent conviction within 18 months after the first conviction, such person shall be punished by a fine of not more than \$300 or by imprisonment for not more than 90 days, or by both such fine and imprisonment.

#### § 253-18. Parking violations.

- A. Except as may otherwise be authorized herein, every person convicted of a violation of any parking provision of Article II, III or IV of this chapter shall be assessed a fine as indicated below for the applicable offense:
  - (1) General violation: \$10.
  - (2) No parking at intersection: \$10.
  - (3) No parking in excess of two hours: \$10.
  - (4) No parking 2:00 a.m. to 6:00 a.m.: \$10.
  - (5) No twenty-four-hour parking: \$10.

- (6) No blocking driveway: \$10.
- (7) No parking on sidewalk: \$10.
- (8) No parking within 15 feet of fire hydrant: \$25.
- (9) No parking in handicapped zone without permit: \$50.
- (10) Uninspected motor vehicle: \$15.
- (11) Unregistered motor vehicle: \$20.
- B. Unless otherwise agreed by the prosecutor, every person who fails to answer, either personally or by properly posted mail, on, or as of, the scheduled Court appearance date of an alleged parking violation shall be deemed delinquent and from that date the applicable fine, as may be assessed, shall be doubled.

# ARTICLE VI Miscellaneous Provisions

# § 253-19. Effect on prior legislation.

All prior ordinances, local laws, or parts of ordinances or local laws, of this Village regulating motor vehicles and traffic are hereby repealed, as of the effective date hereof, except that such repeal shall not affect or prevent the prosecution or punishment of any person for any act done or committed in violation of any ordinance, local law or part thereof hereby repealed prior to the taking effect of this enactment.

# § 253-20. Validity.

If any part, or parts, of this chapter are for any reason held to be invalid, such holding or decision shall not affect the validity of the remaining portions of the within enactment.

## § 253-21. Emergency legislative authority.

Nothing herein contained shall be construed to limit the legislative authority of the Village of St. Johnsville Board of Trustees granted pursuant to Vehicle and Traffic Law § 1640 of the State of New York, as now existing or subsequently amended and upon compliance with proper procedure and majority vote taken of all members of such Board, to order specified vehicle and traffic regulations to take effect during, and continuing in effect, as necessary, following declared public emergencies.

## § 253-22. Emergency chief executive authority.

Nothing herein contained shall be construed to limit the Mayor of the Village of St. Johnsville from properly exercising, by order, the emergency rule authority granted pursuant to Vehicle and Traffic Law § 1602 of the State of New York, as now existing or subsequently amended.

### § 253-23. Emergency police authority.

Nothing herein contained shall be construed to limit any police officer of the Village of St. Johnsville, or any other person properly empowered by law to regulate traffic, from exercising, by order, the emergency rule authority granted pursuant to Vehicle and Traffic Law § 1602 of the State of New York, as now existing or subsequently amended, or to limit any police officer from exercising the removal of illegally stopped vehicles as authorized pursuant to Vehicle and Traffic Law § 1204, as now existing or subsequently amended.

## § 253-24. Enforcement of traffic violations.

#### A. Prosecution.

- (1) In addition to the duly appointed municipal attorney for the Village of St. Johnsville, any complainant police officer, or the Chief of Police, of the Village of St. Johnsville Police Department, despite such police officer or Chief of Police also appearing as a witness, is authorized to prosecute alleged violations of this chapter.
- (2) Nothing herein shall be construed to prevent the prosecutor of any violation hereunder, but only upon his or her express approval prior to the date of trial and in accordance with relevant provisions of the Penal Law, and/or Criminal Procedure Law, of the State of New York, to consent to a disposition of unconditional discharge, conditional discharge, or adjournment in contemplation of dismissal.

# B. Village Justice.

- (1) The Village Justice of the Village of St. Johnsville, in accordance with applicable provisions of law, is hereby authorized to hear and adjudicate, without a jury, all alleged violations of this chapter.
- (2) The Village Justice may, but only upon the express consent of the prosecutor prior to the date of trial and in accordance with relevant provisions of the Penal Law, and/or Criminal Procedure Law, of the State of New York, impose a disposition of unconditional discharge, conditional discharge, or adjournment in contemplation of dismissal.
- (3) Nothing herein shall be construed to limit the Village Justice from dismissing any alleged violation of this chapter in the furtherance of justice pursuant to the criteria presently existing, or as hereafter provided, in the Criminal Procedure Law of the State of New York, or on any legal grounds otherwise applicable under existing state or federal constitutional or statutory law.

## § 253-25. Official forms.

To the extent applicable, all alleged violations of this chapter shall be charged on the existing official forms adopted by the Commissioner of Motor Vehicles pursuant to, and in accordance with, Vehicle and Traffic Law § 207 and all dispositions shall be recorded on all official

forms adopted pursuant to, and in accordance with, Article 60 of the Penal Law of the State of New York,

#### § 253-26. Definitions.

The definition of any word necessary to interpret this chapter shall be first determined by such definition as may be provided in the Vehicle and Traffic Law of the State of New York, as now existing or subsequently amended, and if no such statutory definition exists, then pursuant to applicable case law or administrative decision. If no such definition is determinable by the preceding methods, then the common usage and understanding of such term shall be utilized for necessary interpretation.

#### § 253-27. Subsequent regulation.

- A. Pursuant to the authority granted by Vehicle and Traffic Law § 1640(a) through 1640(d), but except for a proposed increase in penalty, or penalties, under Article V herein or when the procedure of the within provision cannot be accomplished, all regulation of motor vehicles and traffic in the Village of St. Johnsville after the effective date of this chapter may be enacted by formal resolution of the Board of Trustees if such resolution is adopted in accordance with a majority-plus-one vote of the full membership of such Board as then legally constituted.
- B. Any resolution regarding motor vehicles and traffic hereafter duly adopted pursuant to the within section shall be denoted a "traffic regulation" and numerically identified by the year and order of its enactment and shall, for all purposes, otherwise be immediately enforceable under the provisions of this chapter as though originally incorporated therein. A copy of such traffic regulation, duly certified by the Village Clerk, shall, as applicable, be entitled to judicial notice.
- C. Notwithstanding the authority granted pursuant to this section, the Board of Trustees shall, at reasonable intervals as determined by the record of its proceedings and, in any event, at all subsequent times when the filing of this chapter, or an amended version thereof, is required to be made with the Secretary of State, direct that all then existing duly adopted traffic regulations be incorporated in appropriate parts of the text herein and, upon which, such regulations shall be deemed repealed for purposes of independent enforcement.

# § 253-28. When effective.

This chapter shall take effect upon its filing with the Secretary State except as to those parts which may be subject to approval under § 1684 of the Vehicle and Traffic Law and § 46 of the Highway Law of the State of New York and, as to those parts, the same shall take effect from and after the day on which approval in writing is received from the New York State Department of Transportation.
